JOB SUMMARY

Performs working level tasks to maintain County grounds and facilities.

STEP AND GRADE CHARACTERISTICS

This is an entry level temporary position in the Parks and Recreation Department.

ESSENTIAL FUNCTIONS

Maintains public grounds by mowing, edging, and raking leaves.

Assist with event and arena set up.

Cleans parks, parking lots, and restrooms.

Removes trash, clippings, and trimmings from County parks and grounds.

Performs daily maintenance to equipment and transferring equipment between job sites.

KNOWLEDGE, SKILLS, AND ABILITIES

Ability to maintain cooperative relationships with those contacted through the course of work activities. Skill of basic reading, writing, and math skills. Ability to operate power equipment such as lawn mowers, edger, weed eaters, and hand tools.

PHYSICAL DEMANDS

Regularly walk, stand, or stoop. Frequently lift, carry, push, pull, or otherwise move objects weighing up to 80 pounds. Ascend and descend ladders, scaffolding, ramps, poles, and the like.

Use tools and equipment requiring a high degree of dexterity. Walk, stand, crouch, or run on narrow, slippery, or erratically moving surfaces. Distinguish between shades of color.

Communicate via radios. Regularly drives a motor vehicle.

Accommodation may be made for some of these physical demands for otherwise qualified individuals who require and request such accommodation.

WORKING CONDITIONS

Work is performed for sustained periods outdoors and occasionally in hot, cold, or inclement weather. Work requires use of protective devices such as masks, goggles, and gloves. Work exposes incumbent to conditions such as fumes, noxious odors, dusts, mists, hazardous chemicals, and other materials. Work is performed in a noisy place. Work exposes incumbent to possible bodily injury from moving mechanical parts of equipment, tools, or machinery.

Must possess a valid State of Utah Driver's License.
